# Welcome and Opening It's Time to Speak Up! - Kim Bremmer, Ag Inspirations

Kim Bremmer will kick off the conference with her keynote presentation, "It's Time to Speak Up!" Farmers represent the mere one percent of our population that's providing food, fiber, fuel, and pharmaceuticals for the rest of us. Their tenacity and hard work every day is truly something to be proud of and their message of sustainability and continual improvements over time is something to celebrate.

Kim will speak to why being transparent and having conversations about how food is raised is more important than ever, with misinformation continually surrounding our consumers. It's time to speak up and it's time for our voices to be heard!

Kim is a nationally recognized speaker who started Ag Inspirations with a mission to inspire farmers to tell their stories, connect people to where their food comes from, and represent the great success of American agriculture today. She grew up on a dairy farm in north central Wisconsin. She is a mother of two, graduate of UW-Madison, and was a dairy nutritionist for 15 years. Kim also is the executive director of Venture Dairy Cooperative, a new third-party milk verification co-op, qualified through USDA, where she advocates on policy to help protect farmers and promote the future of dairy in Wisconsin. She serves on the Executive Advisory Council for the American Dairy Coalition and the Advisory Board

for Dairy Discovery at Swisslane Farms in Alto, Michigan. Kim is the president of Wisconsin Women for Agriculture, vice president of American Agri-Women, and a regular contributor on Rural Route Radio. She is on the Wisconsin Farm Bureau state board and serves as the local affairs chair for her county Farm Bureau. Kim specializes in communication and connecting with everyday consumers AND is a vocal champion of agriculture everywhere she goes...from the grocery store to the airport.

### Geopolitics of Agriculture in a Multipolar World Jacob Shapiro, Cognitive Investments

### Corn and Soybean Market Situation and Outlook

During this breakout session, seminar presenter Brenda Boetel will review the factors affecting the corn and soybean markets. Forecasts for the current and upcoming market year also will be explained.

Boetel is an extension agricultural marketing specialist for the University of Wisconsin. Her teaching program and extension research provides leadership in educational programming for problems facing the livestock/meat and corn/soybean industries. She teaches

classes at UW-River Falls on price risk management, has authored articles on livestock issues, and has been interviewed by high impact outlets, including the US Farm Report.



### Factors that Impact Beef Cow/Calf Economics in the Next Year

*by Dr. Amy Radunz, Purina & Synergy Cooperative* 

This session will discuss current cow/calf enterprise economics and benchmarks as well as major management strategies that impact profitability. Additionally, the presentation will include strategies to increase the value of calf crop with 23-24 market conditions.

Dr. Amy Radunz is a beef techincal specialist for Purina Mills, LLC and has been an associate professor in Beef Cattle Production at UW-River Falls since 2012. She is

also currently serving as president of the Wisconsin Beef Council and also acts as the Federation of State Beef Councils director on behalf of Wisconsin.



#### Amy comes to Wisconsin from The

Ohio State University, where she served as an extension specialist in livestock youth programs and meat science while earning a Ph.D. in ruminant nutrition and meat science.

### Dairy Dynamics: Navigating Markets and Policies for Present and Future

He brings extensive experience as an educator and analyst to the position, having developed and provided programing on topics including market analysis, outlook and market expectations, risk management, and policy analysis.
